1. **SUMMARY**

- 1.1 Mahon is a practicing advocate and member of the Maisels Group of Advocates.
- 1.2 In May 2022 he was recommended by the Johannesburg Society of Advocates for the conferment of the status of senior counsel.
- 1.3 He is a member of:
 - 1.3.1 the Johannesburg Society of Advocates, where he serves as an elected member of the Bar Council;
 - 1.3.2 the Maisels Group of Advocates, where he serves as an elected member of the Management Committee;
 - 1.3.3 numerous sub-committees of the Johannesburg Bar Council, including the Professional and Fees Sub-Committee, where he serves as secretary and is the chair of the Young Bar Committee and Constitutional Review Committee
 - 1.3.4 the Association of Arbitrators of Southern Africa; and
 - 1.3.5 the Chartered Institute of Arbitrators (UK).
- 1.4 He practices primarily in the fields of:

- 3.1 Mahon is in his 17th year of practice as an advocate.
- 3.2 He is routinely briefed to lead junior counsel;

Construction and Engineering Law

- 3.3 He has significant experience with, amongst others, the NEC, FIDIC, JBCC and GCC suites of construction contracts;
- 3.4 He has acted in conjunction with numerous experts practising in varying disciplines such as time impact analysis, programming, civil and structural engineering, quantity surveying, architecture and project management (to name a few);



- 3.5 The quantum of claims in which he has been involved vary greatly and, in numerous instances, have comprised of claims worth billions of Rands;
- 3.6 Due to the fact that construction claims are invariably resolved by way of arbitration or adjudication, the decisions relating to such matters are not publicly reported, as is the case with litigation in court;
- 3.7 The nature of the projects forming the subject matter of claims in which he has been involved have related to, amongst others:
 - 3.7.1 Mining projects;
 - 3.7.2 Dam construction projects
 - 3.7.3 Road construction projects;
 - 3.7.4 Rail maintenance projects;

- 3.9 The issues arising from the aforesaid matters vary greatly and include issues relating to Contractor's Liability, Performance Guarantees, Time Impact and Critical Path Analyses, Extension of Time Claims, and Delay and Disruption Claims.

Company Law

3.10 Mahon has extensive experience in shareholders disputes, disputes relating to duties of directors and auditors and complex interpretational issues relating to the provisions of the Companies Act 71 of 2008. This is reflected in a number of the reported judgments in which he acted as counsel (see annexure "A" hereto);



- 3.11 He has acted in numerous commercial matters over the past number of years, acting for and against some of South Africa's largest and most prominent companies, including banks, mining houses, telecoms companies and other entities listed on the Johannesburg Stock Exchange and other foreign stock exchanges. In many instances, the quantum concerned in such disputes has exceeded billions of Rands;
- 3.12 Notably, he has acted as counsel in:
 - 3.12.1 A range of disputes arising from the JCI group of companies and the erstwhile management thereof by the late Brett Kebble, including the lengthy arbitration proceedings between JCI Limited and Randgold Exploration;
 - 3.12.2 Shareholder claims arising from the collapse of African Bank;
 - 3.12.3 Multi-billion Euro claims against MTN;
 - 3.12.4 The multi-billion rand class action brought by shareholders in Steinhoff against the company, its directors and auditors;

Business Rescue and Insolvency Law

3.13 Mahon has amassed a number of reported judgments in the field of business rescue (See list of reported and noteworthy judgments, annexure "A" hereto). Notably, this includes the first ever reported judgment by the Supreme Court of Appeal of South Africa relating to the application of the Business Rescue Regime in South Africa - Oakdene Square Properties (Pty) Ltd and Others v Farm Bothasfontein (Kyalami) (Pty) Ltd and Others 2013 (4) SA 539 (SCA);

Financial Services and Insider Trading Law

3.14 Mahon acted as counsel in the seminal South African reported judgment dealing with the concept of Insider Trading: Zietsman and Another v Directorate Of Market Abuse and Another 2016 (1) SA 218 (GP) (See list of reported and noteworthy judgments, annexure "A" hereto). This judgment dealt comprehensively with the definitional elements of Insider Trading in a number of jurisdictions, including the United States, Canada and Australia.



3.15 Mahon has regularly appeared as counsel before the (former) Financial Services Board and its appeal committee and has made submissions to the Ombud for Financial Advisory and Intermediary Services relating to provisions of the Financial Advisory and Intermediary Services Act 37 of 2002 and the Financial Services Board Act 97 of 1990.

Constitutional Law

- 3.16 Mahon acted as lead counsel on behalf of the intervening parties who sought and obtained an order from the Constitutional Court which declared the legislative provisions which criminalise the possession, use and cultivation of cannabis, unconstitutional insofar as they prohibit such possession, use or cultivation for private use.
- 3.17 The judgment is reported as <u>Minister of Justice and Constitutional</u>

 <u>Development and Others v Prince and Others 2018 (6) SA 393 (CC)</u> (See list of reported and noteworthy judgments, annexure "A" hereto).

- 3.18 Mahon has received numerous appointments as both arbitrator and adjudicator in a broad spectrum of disputes.

3.20 Apart from numerous appearances as counsel in international, foreign based arbitrations, Mahon has been admitted to practice in the court of Botswana in a number of disputes, where he has represented government parastatals in various matters and has prepared opinions for consideration by the National Executive (Cabinet) and Government Departments.

7. TRANSFORMATION

The Mahon Foundation

- 7.1 In 2013, Mahon founded the Mahon Foundation, a charitable trust devoted to the execution of educational and outreach programmes in South Africa;
- 7.2 The Mahon Foundation is a registered Public Benefit Organisation in terms of section 30(3) of the Income Tax Act, 1962;



7.3 Initiatives:

7.3.1 **Johannesburg Bar Pupillage Bursary -**

7.3.1.1 The foundation has made an annual donation to the Johannesburg Bar Council Pupillage Bursary Fund to provide for bursaries for pupils;

7.3.2 **Junior Briefing Fund**

- 7.3.2.1 The Foundation routinely earmarks funds to facilitate the briefing of historically disadvantaged junior advocates. It accepts applications from any part of this legal supply chain, whether it comes from a prospective junior member of the team, from the leading or senior advocate on the team, from the instructing attorney or from the client.
- 7.3.2.2 Successful applicants have their fees paid for by the Mahon Foundation. It is the Foundation's hope that this will facilitate the inclusion of historically disadvantaged advocates on legal teams, with the concomitant exposure to quality work and the opportunity to demonstrate his or her abilities to the client and to the instructing attorney.

7.3.3 Financial Assistance

7.3.3.1 The initial years of practice for any advocate can be daunting. Building a stable and steady practice takes time and the financial burden during this difficult period can be overwhelming. It therefore endeavours to assist where it can by making funds available to applicants to assist them in meeting their financial obligations to the Bar Council and to their Groups.

7.3.4 Bursaries, Scholarships and Schooling Equipment



- 7.3.4.1 the provision of bursaries in 2020 to a total value of R500 000 to 5 previously disadvantaged students¹ to study their LLM through the University of the North West;
- 7.3.4.2 the provision of bursaries in 2021 to a total value of R850 000 to 10 previously disadvantaged students² to study their LLM through the University of Johannesburg;

7.3.4.11 other community outreach programmes.

Upliftment of Black and Female Counsel

- 7.4 Mahon practices almost exclusively with the assistance of a second junior counsel;
- 7.5 Whenever he is able to do so, he attempts to procure the involvement of a junior from a historically disadvantaged background;
- 7.6 He has, in the circumstances, been briefed with the assistance of at least **30** different juniors in at least **69** different matters. Of those juniors:
 - 7.6.1 in 62 matters (90%) the junior has been either black or female;
 - 7.6.2 in 7 matters (10%), the junior has been a white male;
 - 7.6.3 in 45 matters (65%), the junior has been black; and
 - 7.6.4 in 40 matters (58%), the junior has been female.
- 7.7 A schedule detailing each of the matters and the counsel involved, can be provided on request.
- 7.8 Mahon has successfully mentored 5 pupils through pupillage. Of these, two are black males, one is a black female, one is a white female and one is a white male. He is currently a mentor to his sixth pupil, a black female.
